

Sampling Collection Instructions for FFPE Sample

Kit components

- 1 Test requisition form
- 1 Specimen instructions
- 1 FFPE slide mailer (for 10 unstained slides)
- 1 FFPE slide mailer (for 1 H&E slide)
- 10 Microscope slides
- 1 Biohazard plastic bag
- 1 FedEx® ClinPak with "Exempt Human Specimen" lab

Specimen requirements

Tissue sample size

- 10 FFPE unstained slides for NGS (positively charged and unbaked at 4–5 microns thick)
- 1 H&E stained slide*
- Use standard fixation methods to preserve nucleic acid integrity. 10% neutral-buffered formalin for 6–72 hours is industry standard.

Surface Area

- Minimum: 25mm² (Area 25mm² and thickness 5 µm on glass slide)

Tumor Content

- Optimum: 30% TN
- Minimum: 20% TN
- Storage: Room temperature (15–25°C)

*** On the H&E slide, circle the area with the greatest tumor content.** Failure to follow these instructions will lead to delayed processing of the samples and delayed turnaround time.

Prepare specimen :

1. FFPE slides: prepare 10 consecutive unstained FFPE sections and 1 H&E stained slide both at 5 µm thick, on glass slides. 30% or higher malignant tumor content is required. Please hand-number the serially sectioned unstained slides (1-10) to indicate the order in which they were cut. Each slide must be properly numbered and labeled and placed into slide mailers.
2. Per CAP guidelines, patient material must be labeled with two identifiers.

Ship

1. Place completed test requisition form (TRF) and any other attachments into the Inocras Specimen Shipping Kit.
2. Place the specimen shipping kit (including samples and paperwork) into the provided clinical shipping pack, first ensuring that primary specimen containers (e.g. slide mailers) is labeled with two patient-specific identifiers. Seal the shipping pack. Confirm "Exempt human specimen" label checked on FedEx® ClinPak. Inocras's FedEx Account Number is 685142600. Call 800.463.3339 to request a pick-up or drop the package at your site's designated FedEx pick-up location and ship sealed shipping pack
